WHOLESALE ACCOUNT APPLICATION

WHOLESALE ACCOUNT QUALIFICATIONS:

- You must qualify as a Natural Health Professional: Health Practitioner (ND, NMD, MD), Naturopathic Doctor, Nutritionist, Herbalist, Doctor of Chinese Medicine, Homeopathic Doctor, Doctor of Ayurvedic Medicine, Chiropractor, Massage Therapist, Acupuncturist, Health Food Store, Natural Grocer or Health Food Reseller.
- You must be an independent natural health professional and NOT a distributor, large retail chain or franchise. Wholesale accounts are for product resale to the public, and not for distributor resale to other businesses. Accounts are not to be used solely for personal use.
- Place of business must be a physical (brick and mortar) location open to the public to walk in and view/purchase natural products.
- Place of business must contain a definitive area dedicated to health supplements and natural products (i.e. Dietary supplements, essential oils, natural cosmetics, natural and organic foods). *Some applicants may be required to provide pictures of their business in order to process their application.*

IMPORTANT INFORMATION: (Please read our Policy Statement for a complete list of company policies)

- New accounts are placed on credit/debit card terms only. After a period of six months (from date of first order) and a history of at least three paid orders, new customers may fill out a credit application (applications may be obtained through mail, fax or email by calling our office or online at wisdomoftheagesllc.com) for consideration of change in payment terms (Net 30, COD or Due on Receipt).
- New accounts may be approved only after the wholesale application has been filled out entirely, signed by the business owner, and all requested documentation has been received from the applicant. After approval, new accounts will be set up in our system upon the first order placed. Approved applications will be held for a maximum of two weeks. If no order is placed within two weeks of application approval, those applications will be terminated and all documentation destroyed.
- All applications for businesses outside the US: Wisdom of the Ages LLC is not responsible for shipments lost, seized or confiscated. Please check with your local government for approval.
- Shipping Procedures: Wisdom of the Ages will only ship to a wholesale customer's pre-approved shipping address that has been verified to belong to the wholesale customer. We will not drop ship orders to other locations.
- Returns Procedures: Products are 100% guaranteed. Returns are subject to a 15% restocking fee after 90 days. Wisdom of the Ages reserves the right to limit returns, refuse and/or place additional restrictions on returns for any reason.
- Wisdom of the Ages reserves the right to refuse applications from businesses for any reason, e.g. businesses that do not qualify or are not a "good fit" for our products. Wisdom of the Ages may also close business accounts for any reason, including businesses that misrepresent themselves.
- Resellers may NOT: sell our products on online marketplaces (Amazon, Ebay, Walmart, Jet, etc.); purchase our products solely for personal use; distribute our products to third party resellers; sell under undisclosed business names or websites; sell our product under MAP guidelines. WISDOM OF THE AGES LLC POLICY STATEMENT

INTRODUCTION

Wisdom of the Ages recognizes that our success is tied to the success of our select authorized resellers. In order to protect our shared business interests, as with all companies, some company policies are necessary. As the sale of our unique line of natural products grows and evolves, we are focused on meeting that growth with policies that protect all of our authorized resellers and consumers.

Wisdom of the Ages is committed to (1. selling to knowledgeable natural health professionals, (2. offering excellent customer service by selling directly to our resellers (not selling through distributors), and (3. maintaining reasonable profit margins for all of our authorized resellers, and (4. Protecting our brand and ensuring the legitimacy of our products online.

AUTHORIZED RESELLERS POLICY

Reseller Eligibility: As a company that produces a unique line of natural health supplements, Wisdom of the Ages finds it in the best interests of the consumer to find knowledgeable natural health professionals to sell our products. Our authorized resellers must meet a predetermined standard of eligibility and Wisdom of the Ages reserves the right to determine reseller eligibility at our sole discretion.

Reseller Account Use: Reseller accounts allow purchase of our products at wholesale prices and as such are to be used in acquisition of wholesale products for retail sale, and are not to be used solely to acquire our products at discounted prices for personal use.

Online Resellers: resellers may only sell Wisdom of the Ages products in their brick and mortar store, professional building and on their own business website where they are the exclusive website owner. Beginning November 15, 2019 Wisdom of the Ages will not allow resellers to sell our products on any online marketplace including, but not limited to, Amazon, Ebay, Walmart, Alibaba, AliExpress, Newegg, Bonanza, Etsy, Facebook Marketplace, Jet, Wayfair, Pricefalls, Overstock, Wish, Google, Rakuten, Shopify, etc. without express written permission from Wisdom of the Ages. Resellers selling on any online marketplace on or after November 15, 2019 (without written permission) will have their reseller accounts immediately closed.

Resellers May Not Be Distributors: Wisdom of the Ages does not sell to distributors, and only sells to qualified authorized retailers who resell our products directly to the consumers. Wisdom of the Ages is the exclusive distributor of Wisdom of the Ages products and as such reserves the exclusive right to sell our products to resellers. Any reseller who purchases product from Wisdom of the Ages and distributes our products to third party sellers is in violation of our policies and is not eligible to purchase our products. Wisdom of the Ages monitors the internet and diligently investigates all reports of seller abuse.

Resellers Must Disclose All Business Names and Websites: Wisdom of the Ages requires all resellers to open their reseller account using the business name they intend to sell our products under, and to disclose all other business names and websites they will be using to sell our products, including but not limited to DBA's, chain stores and multiple business websites. Any reseller using an undisclosed name or website to sell Wisdom of the Ages products is in violation of our policies and is not eligible to purchase our products.

Intellectual Property Rights: Wisdom of the Ages images and product descriptions are protected by copyright and may not be reproduced without permission. Wisdom of the Ages images and descriptions obtained from www.wisdomoftheagesllc.com, catalogs, brochures or an authorized reseller's site may not be used without permission from Wisdom of the Ages. While Wisdom of the Ages allows our authorized resellers to use our copyrighted pictures and descriptions in accordance with our policies, we do not authorize the use of copyright images and descriptions on unauthorized marketplaces or to unaffiliated third parties. Wisdom of the Ages' name and logo are protected by trademark laws, and as the exclusive property of Wisdom of the Ages, may not be used or reproduced without permission.

SHIPPING POLICY

Wisdom of the Ages will only ship to a reseller's pre-approved shipping address that has been verified to belong to the reseller. We will not drop ship orders to other locations. Wisdom of the Ages is not responsible for international shipments lost, seized or confiscated. Please check with your local government for approval.

RETURNS POLICY

Wisdom of the Ages products are 100% guaranteed. Returns are subject to a 15% restocking fee after 90 days. Wisdom of the Ages reserves the right at its sole discretion to limit returns, refuse and/or place additional restrictions on returns for any reason. Wisdom of the Ages will not accept returns on any products with an expiration of one year or less.

WISDOM OF THE AGES DISCLOSURE OF RIGHTS: Wisdom of the Ages reserves the right at its sole discretion to refuse applications from businesses for any reason, including but not limited to businesses that do not qualify or are not a "good fit" for our products. Wisdom of the Ages, at its sole discretion, reserves the right to refuse to do business with or to discontinue doing business with anyone for any reason, including but not limited to, resellers who are in violation of Wisdom of the Ages policies, any business or person we deem ineligible to sell our products, businesses that misrepresent themselves, sell our products online or otherwise under a different name without prior notification, change ownership without notification, violate good business practices, fail to disclose any change in business that would affect their account eligibility.

MINIMUM ADVERTISED PRICE (MAP) POLICY

In recognition of the time, effort and knowledge our authorized resellers invest in the marketing and sale of our products, Wisdom of the Ages has established a Minimum Advertised Price (MAP) Policy that all resellers must follow for advertising Wisdom of the Ages products. Our MAP Policy protects our reseller's profit margins while discouraging price wars resulting from price-based advertising that ultimately devalues and threatens the sustainability of our unique line of products. The intention is not to interfere with the business of our resellers, but rather to enable resellers to maintain sustainable business practices by allowing for a reasonable profit margin and protect the consumer's ability to continue to receive excellent service and support. Our MAP policy is as follows:

1. The MAP policy applies to advertised prices of MAP products, not the price at which MAP products are actually sold or offered for sale in store or over the telephone.
2. The MAP policy applies to all Wisdom of the Ages brand products. MAP pricing can be found on our current Price Sheet/ Order Form which is located on our website and placed inside every reseller order. MAP products must be advertised at or above MAP.
3. The MAP policy applies to all advertised prices of MAP products in any and all media, including but not limited to websites, online marketplaces (e.g. Amazon, Ebay, Walmart, etc.), social media sites, apps, or any other electronic media.
4. Website features such as "click for price," automated "bounce-back" pricing e-mails, pre-formatted e-mail responses, forms, paid search ads, shopping comparison ads, internet landing pages, automatic price display for any items prior to being placed in a customer's shopping cart and other similar features are considered to be communications initiated by the reseller (rather than by the consumer) and thereby constitute "advertising" under this MAP policy.
5. This MAP policy also applies to any advertisement which Wisdom of the Ages determines, in its sole discretion, is designed or intended to circumvent the intent of this MAP policy, such as coupons, percentage off, buy one get one, giveaway, rebate or post-order benefit, social media promo code, solicitations for group or recurring purchases and the like.
6. Resellers are responsible for ensuring all advertised pricing for Wisdom of the Ages brand products are at or above MAP on all internet sites and search engines.
7. The MAP policy does not apply to brick and mortar in-store advertising.
8. Free Shipping and/or handling, 0% sales tax, or free financing promotions do not violate the MAP policy.
9. It is not a violation of MAP policy to advertise that a customer may "call for price" or "email for price," or to use similar language so long as no price is listed.
10. It is not a violation of this MAP policy to advertise in general that the reseller has "the lowest prices" or will match or beat its competitors' prices, or to use similar phrases; so long as the reseller does not include any advertised price below MAP and otherwise complies with this MAP policy.

BUNDLING POLICY

"Bundling" or advertising MAP products for sale together with other products will violate this MAP policy when the advertised price of the bundle is clearly discounted in an attempt to circumvent this MAP policy and/or the product bundled with the MAP product is conspicuously incompatible.

POLICY ENFORCEMENT

Wisdom of the Ages recognizes that resellers are free to sell products at any price they choose, without consulting Wisdom of the Ages. Similarly, Wisdom of the Ages will exercise its right to make its own decisions regarding authorized resellers account eligibility, availability of supplemental marketing materials, product sales and promotions.

Wisdom of the Ages reviews the advertised prices of sellers, either directly or via the use of third-party agencies or tools. Sellers are expected to provide reasonable cooperation in any Wisdom of the Ages investigations regarding possible MAP or other policy violations. Hindering, obstructing, delaying, or otherwise failing to cooperate with a Wisdom of the Ages policy investigation is a violation of our policies and places the reseller's account at risk of being closed.

Wisdom of the Ages policies will be enforced by Wisdom of the Ages at its sole discretion and may be enforced without notice, although Wisdom of the Ages will make attempt to give notice whenever possible. Wisdom of the Ages reserves the right to delay or cancel any pending orders, restrict future orders, suspend or close a resellers' account for any reason, including violations of the provisions of any Wisdom of the Ages policy. Policy violations that result in the closure of a reseller's account will automatically void our 100% product satisfaction guarantee and product returns will not be accepted from those resellers.
